**NationsClassroom FULL Refund Program Benefits:** for your convenience and protection you have been automatically enrolled in the NationsClassroom Full Refund Program. The program provides you with a full refund (less the program fee) in the event you, the tour director, school or school administration need to cancel any time prior to departure. Reasons for cancellation include emergency illness, injury, death in the family, employer termination, job loss or relocation. The program also provides transportation home in the event of a personal emergency. The program provides a refund of the full tour price less the program fee. This program is only available at the time of registration and will be added to your installments and will be shown in your final statement. NationsClassroom must receive your cancellation request in writing before the trip departure. You may choose not to be enrolled in this program by checking the designated box below. **\*This is an optional program and is not part of the initial \$99.00 deposit.\***

**No**, I do not want to purchase the Full Refund Program. I understand that my decision is final and I may lose up to 100% of the trip cost if I, the Tour Leader, School or School Administration must cancel.

The FRP fee is \$89.00 and is based on your tour price.

Exclusions-The NationsClassroom FULL Refund Program does not make refunds in the event the trip is cancelled as a result of the following: an act of God, war (declared or undeclared), terrorism or civil unrest.

\*Fees for merchandise, returned checks, late payments and late registrations are not refundable.

### **TERMS AND CONDITIONS**

**The Trip Price Includes:** Round trip transportation, hotel accommodations, motor coach or vans, three meals per day while on tour, sightseeing, trip leader, admissions, taxes and gratuities, accident-related medical and dental insurance, customer service and accounting. We are an all-inclusive tour agency and do not offer ground packages.

**Not included:** Any fuel, security or baggage surcharges imposed by the airlines or bus companies, installment fees for accounting, Full Refund Program\*, processing fees or merchandise.

**Registrations:** You are encouraged to register online at [www.nationsclassroom.com](http://www.nationsclassroom.com). Please register early, as all registrations are processed on a first come, first served basis. The registration fee of \$99.00 is non-refundable and is due no later than October 31, 2015. All late registrations will be accepted based on the availability of space on the bus and/or the airlines. Any increase in airfare will be passed on to late registrants.

**Group combinations:** Price is based on 40 paying participants per bus for the trip unless otherwise stated. Should your group have fewer than 40 payees per bus, an increase in cost may be incurred. The company may combine small groups to help lessen the cost. Flexibility is required as dates, format and itinerary may need to be changed and is at the sole discretion of NationsClassroom to make these changes.

**Hotel accommodations:** Students will be placed four to a room with students of the same gender, and in some cases five to a room with a roll-away. Adults will be placed in rooms also according to gender, except in the case of married adults. Double and single room charges are additional.

**Flights:** We reserve flights on major carriers. We cannot guarantee non-stop flights, and in some cases, the group will have to be on split flights. We cannot guarantee a specific airport or airline. While we attempt to get groups out of their preferred airport, it can never be guaranteed so you must be prepared to depart from airports that may be a significant distance from your home. Seating assignments will be made by the airlines, and upgrades, stopovers, changes and use of frequent flyer mileage are not possible. NationsClassroom is not responsible for schedule changes, mechanical or weather delays that may occur. Please allow two days of flexibility on each side of your student's travel dates for contingencies. Any baggage fees charged by the airline are the responsibility of the individual traveler at time of check in.

**Sponsorship:** Unless otherwise noted, this tour is not sponsored by any school, school district or public entity, and is organized by a private company, NationsClassroom. NationsClassroom and the trip leader reserve the right to refuse or cancel a registration at their discretion.

**Behavior:** While traveling, all participants will be expected to abide by local laws, including those concerning drugs or alcohol. They will also be responsible for any personal calls or incidental personal expenses, or any damage done to the buses or hotels while on tour. All participants will be required to sign a behavior contract prior to traveling. Breaking these laws and rules may be grounds for being sent home early from the trip at the student's expense.

**Payments:** The payment schedule is as follows: Register by October 31, 2015 with your initial deposit of \$99.00, and choose from one lump sum payment or the NationsClassroom

automatic EZPAY program. There will be six more equal installments billed to the payment source which you used to register. These installments will take place on the 5th of each month beginning on December 5, 2015 and ending May 5, 2016. Should you choose to opt out of the EZPAY program, 50% of the total purchase price is due by February 5, 2016 and the balance must be paid by May 5, 2016. You will be sent a detailed statement upon registration and at the conclusion of each transaction. NationsClassroom accepts VISA, MASTERCARD, DISCOVER and Personal Checks. All checks should be written out to NationsClassroom. There will be a fee of \$35.00 if your check is returned. If your account is unpaid at the final deadline you will be assessed a \$49.00 late fee.

**Cancellation policy:** The cancellation policy is as follows. The company incurs booking costs as soon as a registration comes in. All cancellations must be made in writing. Please include the date, student name and school number. Cancellations are determined solely by the date they arrive in the NationsClassroom office regardless of the reason. The policy applies to each individual registration as follows: 70 days or more prior to departure: NationsClassroom will retain 25% of the trip cost. 69-36 days prior to departure: NationsClassroom will retain 50% of the trip cost. 35 days or less: We regret that no refund will be issued. Cancellation due to rescheduling: In the event the departure date needs to be rescheduled for any reason, the standard cancellation charges remain effective. Trip funds are not transferable to other participants.

**Fundraising:** Fundraising money will not be returned to individual families, nor will merchandise costs, late fees and returned check charges.

**Additional Provisions:** NationsClassroom cannot be held responsible for events beyond its control, such as acts of God, war, terrorist activities, and incidents of politically motivated violence, illness or quarantine, strikes or government restrictions. We reserve the right to cancel any tour for any reason, in which case you will receive a refund. All photographic images and video taken by NationsClassroom while on tour are property of NationsClassroom and may be used by NationsClassroom without compensation or notification of individuals therein. NationsClassroom cannot be held responsible for loss of personal property including money, and is not responsible for locating lost property. The suppliers providing travel services and accommodations are independent contractors and not agents. NationsClassroom cannot be held responsible for personal injury, property damage, or loss of earnings from any event whatsoever caused by hotels, railways, airlines and all sub-contracted services. The participants shall indemnify, defend and hold harmless NationsClassroom and its officers, directors, partners, agents, members and employees from and against any and all demands, claims, damages to persons or property, losses and liabilities, including reasonable attorney's fees, except to the extent and percentage attributable to NationsClassroom negligence or wrongful action. All parties agree that in the event of legal action concerning this agreement, all litigation shall be brought only in Henrico County Virginia and that such litigation shall be decided pursuant to the laws of Virginia.
